NOTIFICATION

Port Blair, dated the 9th October, 2009.

No. 115/09/F.No.1-30/2009-DES.— In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with the Ministry of Home Affairs Notification No.U-14039/2/83-ANL dated 21st February, 1985 and in supersession of this Administration's Notification No. 47 dated 13.3.2006, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following rules regulating the method of recruitment to the post of Junior Investigator borne in the Amalgamated Statistical Cadre of the Andaman and Nicobar Administration, namely:-

1. Short Title and Commencement:-

- i. These rules may be called the Andaman and Nicobar Administration (Junior Investigator) Recruitment (Amendment) Rules, 2009.
- ii. They shall come into force on the date of their publication in the Official Gazette.

2. Number of Posts, Classification and Scale of Pay:-

The number of posts, their classification and scale of pay attached thereto, shall be specified in paras (2) to (4) of the Schedule annexed hereto. Duty Chart of Junior Investigator is as annexed at Annexure to these rules.

3. Method of Recruitment, Age limit, Qualification:-

The method of recruitment to the post, age limit, qualifications and other matters relating thereto shall be specified in paras (5) to (14) of the said schedule.

4. Disqualification:- No person,

- (i) who has entered into or contracted a marriage with a person having a spouse living, or
- (ii) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Lt. Governor, A & N Islands, if satisfied that such marriage is permissible under the personal law, applicable to such person and the other party to the marriage and there are other grounds for doing, exempt any person from the operation of this rule.

5. Power to Relax:-

Where the Lt. Governor (Administrator), Andaman and Nicobar Islands is of the opinion that it is necessary or expedient to do so, it may, by order and for reasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of posts or persons.

6. Saving:-

Nothing in these rules shall affect reservations and other concessions, required to be provided for the Scheduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

No.1-30/2012/DES.— In exercise of the powers conferred by the provision to Article 309 of the Constitution of India read with the Government of India, Ministry of Home Affairs, New Delhi's Notification No. U-14039/2/83-ANL dated 21st February, 1985 and in pursuance of Department of Personnel & Training's OM No. AB. 14017/13/2016-Estt.(RR) dated 9.8.2016, the Lieutenant Governor (Administrator), Andaman and Nicobar Islands hereby makes the following Amendments to the Recruitment Rules to Group-C post of Junior Investigator in the Directorate of Economics & Statistics, Andaman and Nicobar Administration published in the A & N Extraordinary Gazette Notification No. 122 dated 9th October, 2009 :-

1. Short title and commencement :-
